You have got information that in your district manual scavenging practices are continue to practice and three scavengers have died few days back during cleaning sewerage. In inquiry you have found following observations. i) People from a particular community (Manual scavenging is rooted in India's historical system of hierarchy and exclusion: The caste system. As per recent data by the government, out of 43,797 identified manual scavengers, 42,000 belong to the Scheduled Castes (SC) or Dalits) are into this practice. ii) In inquiry they told to media persons that they have been practicing it for ages and it has been their traditional occupation. iii) Some other argue that since they don't have any other source of regular livelihood, therefore they don't have any alternative. iv) They others said they don't know about government scheme like The Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013. V) some of them told that they don't know that manual scavenging is illegal as per the above law and majority of them are still willing to work in same work due to thei (attitude) You also know the various reasons behind it and also despite several government initiatives the cases of manual scavenging could not be stopped. Also While distributing the Swachh Survekshan Awards in November by the Ministry of Housing and Urban Affairs, Former Presiden Ram Nath Kovind called manual scavenging a shameful practice, eradication of which is not only the responsibility of the government but also of the society.







You are district magistrate and a tragic incident took place at a government health care center in your district in which nearly 100 infants, suffering from acute decease, died due to oxygen deprivation in last 24 hours. Preliminary enquiry by you revealed that hospital administration and oxygen supplier are to be blamed for the death of children. There was overwriting in the log book containing the details of purchase and re-filling of oxygen cylinders and head of anesthesia department responsible for ensuring continuous flow of oxygen to the hospital wards, was absent during the incident. The enquiry report also demands strict action against oxygen supplier for stopping oxygen supply – which it termed as an —emergency service. Media reports suspect healthcare firm and liquid oxygen supplier of an oxygen cylinder theft (acket) at hospital. There is huge protest across the district by parents against the district administration and also questions are raised by opposition leaders and media on efficiency of administration.
